TITLE: C-25-15 – Approval of Contract with Oracle America, INC for

Managed Services

ACTION: Recommend Approval

Summary:

Approval requested to increase the current managed services agreement with Oracle to include Amendment 2. Oracle will provide up to two thousand seven hundred forty-four (2,744) hours of consulting assistance related to your Oracle Utilities Customer Care and Billing application ("CC&B") as a part of this agreement.

This contract will be procured pursuant to the authority contained in section 17(a)(19) of the Rules Governing Procurement for the Albuquerque Bernalillo County Water Utility Authority (Water Authority). Resolution R-18-14 requires board approval for any purchase in an amount exceeding \$500,000.

Approval of this item will delegate signature authority to the Executive Director to increase this contract with Oracle for the addition of these services. Approval of this item shall also serve as delegation of authority for the Executive Director to approve all future amendments to this purchase, if any.

FISCAL IMPACT:

\$745,000.00 including New Mexico Gross Receipt Tax. The Water Authority has budgeted funds to cover this agreement.
