**TITLE: R-21-12 – Amendment to the Approved Capital Implementation Program of the Albuquerque Bernalillo County Water Utility Authority for the Fiscal Year Ending June 30, 2022**

**ACTION: Recommend Approval**

**SUMMARY:**

The Water Authority approved C-20-38 – 2021 State Legislative Priorities at the December 9, 2020 board meeting. The Governor has signed HB285 – Capital Outlay Projects that include the following awarded projects:

Southside Water Reclamation Plant (SWRP) Outfall Realignment	\$322,500

**FISCAL IMPACT:**

This action requests Board approval of the proposed amendment to the FY22 Capital Implementation Program (CIP) for appropriating projects awarded from HB285 Capital Outlay Projects from the 2021 State Legislative Session.
