TITLE: C-24-19 – Contract with Environmental Systems Research Institute Inc. for ArcGIS Software & License

ACTION: Recommend Approval

Summary:

Requesting approval to delegate signature authority to the Executive Director to enter into a contract with Environmental Systems Research Institute Inc. (ESRI), to provide an Enterprise License Agreement (ELA) for GIS software to operate the Albuquerque Bernalillo County Water Utility Authority's (Water Authority) GIS systems. The ELA provides open ended licenses to ESRI's suite of products to provide offline, online and paper mapping capabilities for Water Authority staff.

If approved by the Board, an Agreement will be executed between the Water Authority and Vendor to enable Vendor to provide Enterprise software, support, training and consulting for the Water Authority's GIS systems including mapping, WebGIS Portals, Insights Data Analysis, GIS Dashboards, Hydrant and Valve mobile inspections.

This contract will be procured pursuant to the authority contained in section 7(a)(19) of the Rules Governing Procurement for the Albuquerque Bernalillo County Water Utility Authority. Resolution R-18-14 requires board approval for any purchase in an amount exceeding \$500,000.

Approval of this item will delegate signature authority to the Executive Director to issue a PO for these licenses. Approval of this item shall also serve as delegation of authority for the Executive Director to approve all future amendments to this agreement, if any.

Dear Cody:

As a follow-up to our meetings regarding an Enterprise Agreement for ABCWUA, I am providing proposed pricing and key business terms below.

The Esri Enterprise Agreement (EA) will remain in effect for three (3) years and grant ABCWUA uncapped access to the Esri products listed below.

Maintenance on all listed software, including maintenance on listed software deployed prior to the agreement, is included for the term of the EA.

The agreement will be effective on August 31, 2024, and requires a firm three-year commitment.

Albuquerque-Bernallilo County Water Utility Authority has shown a stellar usage of ArcGIS technology and a team of highly proficient users that support work across the ABCWUA business. Over the next 3 year term, ABCWUA will be migrating to the Utility Network and completing their migration to ArcGIS Pro. ABCWUA's GIS team fuels the organization; they maintain GIS records valued at over \$5bn, including 3,000+ miles of water supply pipeline and 2,400+ miles of sewer collection pipeline. They maintain 214,000 customer connections supporting approximately 650,000 citizens across the Albuquerque-Bernallilo County territory.

Although your organization has already deployed a considerable amount of Esri technology, our experience with similar customers indicates there is significant potential to apply GIS in many additional areas within your organization. For these reasons, we believe your organization will greatly benefit from an Enterprise Agreement. An EA offers numerous benefits including:

- A lower cost per unit for licensed software
- Substantially reduced administrative and procurement expenses
- Maintenance on all Esri software identified in this proposal and deployed within the organization
- Complete flexibility to deploy software products when and where needed
