#### Item 4 – Public Comment

# Item 5 – Texas vs. New Mexico Update – Grace Haggerty, Interstate Stream Commission

Presenter discussed the importance of New Mexico Interstate Compact, delivery obligations to Elephant Butte, cumulative departures from 1940-2024 and annual deliveries, Middle and Lower Rio Grande investments, judicial status on TX v. NM, planning efforts, regulatory framework, explained the Water Security Planning Act.

## Item 6 – Water System Overview – Joel Berman

Presenter provided water system background, discussed supplies of groundwater and surface water, components of water pumping, described treatment, storage, and distribution facilities.

## Item 7 – Collection System Overview – Mark Holstad

Presenter discussed components of the collection system, types of sewer pipes, lift stations, forced mainlines, vacuum stations, grinder systems, types of odor and corrosion systems, how to prevent odors, sewage quality from the reclamation plant, chemical costs, interceptors, logistics of soil arching, and corrosion management strategy.

## Item 8 – Water Report – Amos Arber

Presenter discussed the Water Report. Provided that we are at 43 percent surface water production, DSCI is 300, gallons per capita per day is 127, currently at drought advisory stage, continue to increase public education on water conservation and drought measures, discussed temperature and precipitation, also the seasonal outlook and drought outlook.
