Ground rules

Let people speak for themselves: If someone is on the board freom a community let them speak

Be Present: Leave distractions outside the room. Step outside for calls, etc.

Move up, Move Up: If you talk a lot, move up your listening; if you tend just to listen, move up your sharing, so that we have equal communication.

Assume Best Intentions: Be Aware of Impact: If you know you've unintentionally hurt someone, apologize for the impact.

Be and Stay Curious: Because if you are genuinely curious, you cannot be judgmental, and you will be motivated to learn from one another.

Practice Calling In, rather than Calling Out: Let's do our best not to shame one another. We are all bringing different experiences to the class. This doesn't mean that we don't challenge each other's ideas; it's about how we do it.

For your department, what are the most important racial equity community outcomes related to the issue?

- That all sectors of the WA are aware of the issues that this board deals with and have an opportunity to learn from what we're learning, so that if there's an issue people know what resources are available
- Inspired by something Roberto brought up about RoundUp. How do we make sure to cover everything going on in the community. How do we let people know to let us know about issue.
- **IDEA** Advertising these meetings to the public better since they provide so much information. This might inspire people to bring their issues forward.
- In Water Quality we try to cover the entire city for sampling. Delivering that same water quality for the whole city. We try to hit the areas that are less developed, to the west where there's less development. Initiation where we install mixers etc. in remote reservoirs (tanks). The City has a number of tanks to serve to remote areas. They have long travel times, they're typically in the west, since there's less demand, so the water ages. The Authority has invested, money, studies, materials, to improve.
- Source Water Protection Racial Equity is directly tied to Racial Equity. We work hard to make sure all source waters are protected. Need to make sure the waters that are hard to get to are harderd. Neighborhoods may not even know that there is an issue or impacts. Need all communities to have a voice. We can help add the megaphone.
- We hear a lot about Kirtland, but how do we help to elevate the other issues.
 - **QUESTION** How can the Board build our megaphone.
- IDEA We have our source water protection program, we talk about it programmatically. But we could do an annual update for example we could provide and update that inventory of sources of contamination. Make that more the library more dynamic and accessible. (QUESTION How would we access it? We could output a table and map. This would allow the board to see where they are and then the status of that clean up. It's a combination of lack of money, there's not a lot of attention to it, What happens with site where there is not responsible party. This is an important place where this board can help. Requesting or recommending a VRP program.)
 - Our water surface water goes to the treatment plant
 - Ground water doesn't necessarily with ground water wells
 - GIS will show the overlay contamination that go with water wells
 - If they do crosssect we ramp it up to the situation fixed
 - Some of the sites could hae a future well
 - Could be vapor concerns
 - The drinking water we provide is clean
 - But there are communities that have a concern.
 - The state just became able to regulate vapors. (Where there is an irreigation well)
 - Review together What data do we have, what are we missing

- QUESTION How do we increase the representation on our board of people from diverse backgrounds. Have better representation of communities.
- Source water assessment plan when it comes to equity, how do we get our information out. Many of the contaminant issues are in EJ communities. How do we get this to community groups and associations. You have an impact in your area. Is it impacting you. Is there a vapor intrusion. Is there a risk to a well. We get a lot of information, but how do we equitably communicate that. Do we the board help the PICs do that? How do we get convert information to action. It can be frustrating if communities don't see action. How do we get the funding.
 - **IDEA** Can we crossect the contamination sites with legislative districts to encourage legislators to use capital outlay for clean up purposes?
 - The state by rule is required to find contaminate responsible parties.
 - IDEA: You could create an orphaned site fund. This could be a long term strategic plan for this board.
 - IDEA: Also need a laundrymat fund.
 - Can we help develop a water quality fund
 - those sites that have a resonsible party, that's where locally entities can help bring pressure.
- IDEA Advertising our meetings and agendas to the public. Develop a list of organizations of communities, communities of color, environmental justice communities and organization. Have a targeted lists of contacts.
- Statewide they're talking about the cannabis industry and the potential water impacts. People of color were impacted when it was illegal and now we'll be impacted now that it's legal in terms of water quantity
 - There is also some water quality issues because of the pesticides issues, there is run off issues.
 - In the news, some communities that have medical cannabis have tapped into public water systems,
 - Is the water authority dealing with this.
 - If they are using water authority water, they have to get an account with th authority. Show how much they'll use, paying for infrastructure and paying for impacts to our system.
 - When we did the 100 year plan we accounted for population growth and we look at those curves relating low, middle and high population growth. Our planning is based on medium but we've seen low growth. We haven't seen any permits, we will look at the impact on the curve.
 - Used climate change data in our modeling. We'll be updating that. The model assumed back to back drought years, the reality was in the model. High full allotment from San Juan Chama; Middle: less chama more groundwater.

Data gaps

- From the board perspective, we're missing communities' perspective. I don't think we've checked in with underrepresented and impacted communities.

 - Neighborhoods Saw mill, Duranes, Wells Park (Look at GIS)

 - City councilor to see if they can put it in their newsletter -

 - Any churches in the neighborhood

- PiC agencies where the racial equity aren't s clear we need to dig deeper into the data gap

Step 3. Engage community and stakeholders
