**TITLE: C-18-39 – Approving Contract with Oxbo International for a Self-contained Universal Spreader**

**ACTION: Recommend Approval**

**Summary:**

The Albuquerque Bernalillo County Water Utility Authority (Water Authority) issued the Request for Bids (RFB) to solicit responses from qualified vendors to provide a Self-Contained Universal Spreader, B2019000007.

Approval is requested to enter into an agreement with Oxbo International to provide a Self-Propelled Universal Spreader through the issuance of a purchase order. If approved by the Board, a purchase order will be issued by the Water Authority to enable Oxbo International to deliver a new Oxbo 5105 DNMS model self-propelled applicator/spreader.

The self-contained spreader will be used to spread and till biosolids from the Southside Water Reclamation Plant. This equipment is necessary for the continued operations of spreading anaerobically digested and dewatered sludge.

\$639,509.00 excluding NM GRT for FY19, for which appropriations have already been made.

**1. GENERAL**

The Albuquerque Bernalillo County Water Utility Authority (Water Authority) is seeking a qualified vendor to provide a Universal Spreader that is Self-Contained and Propelled to spread and till biosolids from its Southside Water Reclamation Plant. These biosolids are further described as dewatered, anaerobically digested sludge with the following nominal properties:

- Total Solids content: 21%
- Total Volatile Solids content: 50%
- Bulk density: 2.50 lbs. per cubic yard

The Universal Spreader offered shall meet or exceed the specifications below.

**2. SPECIFICATIONS**

The following specifications are the minimum acceptable for furnishing a Universal Spreader to the Water Authority. Equipment furnished as a result of this solicitation shall meet or exceed the physical and/or performance specifications below, and shall be suitable for use in a harsh environment. The Water Authority may waive any minor exception(s), if doing so is in its best interests. Vendors shall state, as part of their offers, the exact make and model of the unit being offered. The manufacturer's specifications shall be included with your bid and shall include enough information to allow for a thorough review. Failure to provide sufficient information may cause your offer to be considered non-responsive.

- Oxbow 5105
