TITLE: R-20-4 - Amendment to the Approved Capital Implementation

Program of the Albuquerque Bernalillo County Water Utility Authority

for the Fiscal Year Ending June 30, 2020

ACTION: Recommend Approval

SUMMARY:

This legislation provides information to support a request to the Board to approve an amendment to the FY20 Capital Implementation Program (CIP) budget.

FISCAL IMPACT:

This action requests Board approval of the proposed amendment to the FY20 Capital Implementation Program (CIP) for additional funding for various CIP existing projects.

The amendment reallocates additional revenue bond proceeds and reallocation of current projects.

The various increases and decreases include the following:

- Increase of \$10,000,000 appropriated to Fund 28 for the continuation of the rehabilitation of clarifiers at the Southside Water Reclamation Plant (SWRP).
- Increase of \$10,000,000 appropriated to Fund 29 for the completion of the Customer Service and Field Operations Building to centralize resources.
- Increase of \$8,000,000 appropriated to Fund 28 for the San Juan-Chama Water Treatment Plant Dewatering project.
- Increase of \$2,000,000 appropriated to Fund 29 for IT software system upgrades.

Staff recommends approval of the proposed FY20 CIP amendment which increase and reallocates funding to the CIP budget.
